4. Marijuana 101 – What parents need to know

Cpl. Jeff Zientek from the West Allis Police Department special investigations unit talked about marijuana and what parents can look for, including different pipes, soda cans and bottles with hidden compartments and samples of marijuana. 4. Screening Brief Intervention Referral to Treatment (SBIRT)

Julie Whelan Capell from the Planning Council and WAWMCC Evaluator, presented information about the Alliance for WI Youth SBIRT project and the pilot program being

conducted in two school districts in Washington County. Screening, Brief Intervention, and Referral to Treatment is a comprehensive, evidence based approach for prevention,

early intervention and treatment for persons with a substance abuse problem or those at risk of developing a problem. The Washington County pilot program is being conducted in April and May on-line and would be available for use by other school districts. A meeting for AWY member school districts to talk with and ask questions of the Washington County group about their pilot program will be scheduled for this summer.

5. Annual Coalition Membership Survey and WAWMCC Pre-planning Meeting for 2013-2014

Julie Whelan Capell announced the annual membership survey would be emailed to Coalition members by the end of the week.

A strategic pre-planning meeting will be held this summer to look at goals and strategies for Year 5 of the DFC grant and lay the groundwork for the Year 6-10 DFC grant application in 2014.

6. National and statewide initiatives

Smart Approaches to Marijuana (SAM)

- a. Smart Approaches to Marijuana (SAM) is a new national organization looking at marijuana issues. WAWMCC is currently developing a brochure that will include marijuana information.
- b. SAMSHA developed handouts designed for businesses about prescription drug abuse will be shared with the WAWM Chamber of Commerce Wellness Committee for distribution.

Alliance for WI Youth

WAWMCC is a member of the southeastern branch of the organization. Current projects include:

5. Coalition Survey

Julie Whelan Capell, Coalition Evaluator, provided a summary of the latest membership survey. Eighteen members of the WAWMCC participated in the online survey in April 2013 to help assess the progress of the coalition as a collaborative entity. The indicators did not change from last year's survey in April 2012.

A brief overview of the July strategic planning meeting was also given, along with a survey to determine the best time for meeting. Information will be emailed to Coalition members by the end of May.

6. Youth Updates

West Allis Central High School – SADD (Students Against Destructive Decisions) Chapter

Central will be hosting a Ghost Day activity on May 17th to remind students the effects of driving under the influence of alcohol and drugs. Every twenty minutes during the day a bell will toll over the PA system to symbolize the fact that someone has died due to impaired driving. A grim reaper will take “victims” from class and they will wear a black tee shirt and will not speak for the rest of the day. Students from the SADD Chapter have volunteered to be “victims” for this activity.

The SADD Chapter also reviewed and selected a video to be shown before prom during the 75 homerooms to approximately 1350 students. The students made announcements during April for Alcohol Awareness Month, attended Coalition Meetings and volunteered during the Safe and Sober program. Four students participated in the Peers with Purpose training and plan to make presentations to 7th graders at West Milwaukee Intermediate School in the fall or winter. Students are also planning to volunteer for events over the summer including CAAD Tuesday in the Park and National Night Out.

WAWM Learning Center / Dottke High School – Teen Experience

Students from Teen Experience are developing a video based program to share personal stories and challenges and address how to meet those life challenges. They plan to present the video to at-risk middle school students in the future. Students also attended Coalition Meetings and are planning to volunteer for events over the summer including CAAD Tuesday in the Park and National Night Out.

Nathan Hale High School – Peers with Purpose

Hale students attended an all-day training/refresher for the Peers with Purpose program. Peer students then presented twelve programs to over 300 7th graders at Frank Lloyd Wright Intermediate School. The 7th graders were given a pre-test before the Peers presentations. Only 58% of the 7th graders passed the pre-test, while after the presentation by the Peers 97% of the 7th graders passed the post test. Students also volunteered at the Safe and Sober program and made announcements during April for Alcohol Awareness Month. Students are planning on volunteering over the summer for the CAAD Tuesday in the Park.

Thank you to North Shore Bank for their sponsorship of lunch for the peers training.

Shared Journeys – 3 To Get Ready

Students presented a slideshow program showing the effects of alcohol and shared a flyer highlighting the number of bars in WI versus grocery stores and a pamphlet they created about fetal alcohol syndrome. Students also talked about attending 3-To-Get-Ready to share their information and designed t-shirts to be worn at the event.

7. Updates

May Safe and Sober

The Safe and Sober program was held at West Allis Central on April 29th with the topic of Dangers and Consequences of Prescription and Other Drug Abuse. Speakers included Max Radcliffe from the Aurora Family Assistance Program, Beth Heflin and Dan Solarzano from the school district and Detective Sergeant Troy Mass from the West Allis Police Department. There were about 150 students and parents in attendance, 40 students from Central and 35 students from Hale.

Parents Who Host, Lose the Most was also launched at the program with yard signs, posters and window clings available to participants. Signs will be up throughout the community through June 17th to remind parents and students to have a safe and sober prom, graduation and summer.

4. Prescription drug abuse

Detective Sergeant Troy Maas from the West Allis Police Department shared information about prescription drug issues in the community and the drug unit.

- Prescription fraud and doctor shopping down.
- State and nation wide heroin problem with snorting
 - Good news – not affecting schools or students in West Allis. Find more with 18-19 year olds and up.
- Small quantities of marijuana in schools
- April DEA take back day statistics

- 79 pounds from WAPD and 90 pounds from Walgreens on 83rd and Greenfield
 - 512 pounds in collected from West Allis so far this year
 - Next take back day – October 26th from 10:00 am – 2:00 pm at WAPD and Walgreens on 83rd and Greenfield
- There has been a decrease in the number of people getting in trouble for prescription drugs, but can't say from having drop-box in lobby.

5. Strategic Planning: Review and planning for prescription drug abuse prevention

Julie Whelan Capell, WAWMCC Evaluator, coordinated the discussion around strategies and initiatives for prescription drug abuse prevention around strategies and initiatives for underage alcohol abuse prevention, continuing the discussion from the July Planning Meeting.

- Having a portable drop-box that can be taken to different locations throughout the community, such as a senior living centers, businesses, religious organizations. This would be manned by WAPD and Coalition volunteers
- Recruit volunteers to assist with removing pills from packaging at WAPD before disposal
- Better publicize Student and Family Assistance program

The WAPD still offers the Concerned Parent program for parents that will be out of town and leaving teens home alone. Party Patrol will be reestablished. Compliance checks are done every six months, the next coming up in December.

Chief Nasci from West Milwaukee reported there were more underage alcohol violations in the past six months, due to two parties –

There were no OWI for youth. Ten compliance checks were conducted and all passed.
